

**AMENDED
DECLARATION OF DISASTER AND ORDER PROHIBITING OUTDOOR
BURNING FOR ECTOR COUNTY, TEXAS**

WHEREAS, the Commissioners' Court of Ector County, on this the 12th day of December, 2011, has determined that Ector County, has been affected by recent wildland fires and continues to be threatened by high or extreme wildland fire hazard. This threat is caused by abundant fuel and extreme dry and windy conditions across the State of Texas and in Ector County, and;

WHEREAS, the Commissioners Court of Ector County have determined that extraordinary measures must be taken to alleviate the suffering of people and to protect or rehabilitate property,

NOW THEREFORE, IN ACCORDANCE WITH THE AUTHORITY VESTED IN THE ECTOR COUNTY COMMISSIONERS' COURT BY SECTION 418.108 AND 418.014 OF THE TEXAS GOVERNMENT CODE, THE COURT DOES HEREBY PROCLAIM THE EXISTENCE OF SUCH DISASTER AND DIRECT THAT ALL NECESSARY MEASURES BOTH PUBLIC AND PRIVATE AS AUTHORIZED BY THE LAWS OF THE STATE OF TEXAS BE IMPLEMENTED TO MEET THAT DISASTER:

1. That a local state of disaster is hereby proclaimed for Ector County pursuant to Section 418.108 (a) of the Texas Government Code.
2. Pursuant to Section 418.108 (b) of the Government Code, this Declaration of a local state of disaster shall continue for so long as such conditions exist with the exception granted to fireworks under Section 418.108 (i) of the Government Code unless ratified and extended by the Governor of the State of Texas.
3. Pursuant to Section 418.108 (c) of the Government Code, this Declaration of a local state of disaster shall be given prompt and general publicity and shall be filed promptly with the County Clerk of Ector County.
4. Pursuant to Section 418.108 (d) of the Government Code, this Declaration of a local state of disaster activates the Ector County Emergency Management Plan.
5. The purpose of this order is the mitigation of the hazard posed by wildfires by curtailing the practice of outdoor burning, which purpose is to be taken into account in any enforcement action based upon this order.

BE IT THEREFORE ORDERED that the following emergency regulations are hereby established for all unincorporated areas of Ector County, Texas for the duration of the declaration;

(1) Actions Prohibited:

- (a) **THE SALE, USE OR POSSESSION OF ALL FIREWORKS IS RESTRICTED TO 7 A.M. DECEMBER 30, 2011 UNTIL 7 A.M. JANUARY**

2, 2012.

(b) ALL OUTDOOR BURNING OF ANY COMBUSTIBLE MATERIAL IS PROHIBITED. A PERSON VIOLATES THIS ORDER IF HE BURNS ANY COMBUSTIBLE MATERIAL OR ORDERS SUCH BURNING BY OTHERS.

(1) COMBUSTIBLE MATERIALS INCLUDE, BUT ARE NOT LIMITED TO THE USE OF ALL FIREWORKS (EXCLUDING THE ALLOWED USE FROM 7 A.M. DECEMBER 30, 2011 UNTIL 7 A.M. JANUARY 2, 2012) AND ANY OTHER ACTIVITY THAT COULD RESULT IN A FIRE, INCLUDING DISCARDING CIGARETTES, CIGARS OR OTHER FLAMMABLE MATERIALS.

(2) EXCEPTIONS: BURNING OF HOUSEHOLD MATERIALS IN A BURN BARREL WITH AN IRON GRATE, OUTDOOR COOKING IN AN APPROVED BARBEQUE GRILL, WELDING ACTIVITIES PURSUANT TO AN INDIVIDUAL'S EMPLOYMENT AND FIREWORKS PRESENTATIONS BY LICENSED PYROTECHNICIANS WITH APPROVAL OF THE FIRE MARSHALL FOR THE CITY OF ODESSA.

(2) Enforcement:

(a) Upon notification of suspected outdoor burning, the fire department assigned to the location of the fire shall respond to the scene and take immediate measures to contain and/or extinguish the fire.

(b) As soon as possible, a duly-commissioned peace officer shall be sent to the scene to investigate the nature of the fire.


(c) If in the opinion of the officer at the scene and/or the Fire Chief, the goal of the order can be attained by informing the responsible party about the prohibitions established by this order, the officer may, at his discretion, notify the party about the provisions of this order and request compliance with it. In such instances, an entry of the notification shall be made into the dispatchers log containing the time, date, and place of the warning, and the name of the person receiving the warning.

(3) At the discretion of the peace officer and/or Fire Chief, subsequent or flagrant violations of this order may be prosecuted in accordance with the statues and procedures governing misdemeanors.

BE IT ALSO ORDERED that this order may be enforced by any duly-commissioned peace officer and that the venue for prosecution of this order will be the Justice of the Peace Court, Ector County, Texas.

This Declaration and Order shall take effect immediately from and after its issuance and continue until the conditions requiring this declaration and order are over, with the exception granted to fireworks under Section 418.108 (i) of the Government Code unless ratified and extended by the Governor of the State of Texas.




