ECTOR COUNTY LAW ENFORCEMENT CENTER**

The Ector County Sheriff's Department is accepting applications for Jailers for the Ector County Jail. The Jailers will be under the supervision of the Sergeant and the general supervision of the Lieutenant.

PRIMARY DUTIES: Implementation and day-to-day application of plans and operating procedures that are required by the Texas Commission on Jail Standards and the department for the care, custody and control of inmates of the Ector County Jail.

MINIMUM QUALIFICATIONS: Must be a United States citizen; at least 18 years of age; not currently on probation for any criminal offense; not be convicted of a Class B misdemeanor in the last 10 years; not convicted of a Class A in the last 10 years; never have been convicted of a felony offense; be of good moral character; be subject to a thorough background investigation and personal interviews by the Ector County Sheriff's Department; be declared in satisfactory psychological and emotional health by a psychologist, psychiatrist; be discharged from any military service under honourable conditions; be fingerprinted and be subject to a search of local, state, and national records and fingerprint files to disclose any criminal record; not have had a license revoked which was issued by the Texas Commission on Law Enforcement (TCOLE). Applicant must have a High school diploma or GED, be able to pass at TSI test or Compass test reading and comprehension exam; be able and have a valid Texas Driver's license with insurable driving record.

SPECIAL REQUIREMENTS: **Non-certified** jailers must be able to obtain proper jailer licensing within one year of employment. **All former county jailers that were issued temporary jailer's license and did not become a TCOLE certified jailer:** you must be able to obtain proper jailer licensing prior to an offer of employment with Ector County; all classes will be at one's own expense; and during their own personal time. **Certified jailers** must have a current Jailer's license.

TSI or Compass Test results are required with employment application and the TCOLE Personal History Statement packet.

SALARY: \$23.23 p/h with excellent benefits. Twelve hour shifts; (7am-7pm, or 7pm-7am) Sunday thru Monday plus weekends and holidays.

DEADLINE: Until sufficient applications have been submitted for consideration

Please apply in Human Resources Department at Ector County Annex Building 1010 E. 8th Street, Room 126, Odessa, Texas. Ector County does not discriminate based on race, color, national origin, sex, religion, age and disability in employment or the provision of services.

NOTICE: Federal law requires all employers to verify the identity and employment eligibility of all persons hired to work in the United States. This employer will provide the Social Security Administration (SSA) and, if necessary, the Department of Homeland Security (DHS), with information from each new employee is Form I-9 to confirm work authorization. Passing a pre-employment urinalysis drug screen is required.
