ANY MOTIONS FOR CONTINUANCE OR AGREED SCHEDULING ORDERS MUST BE FILED ON OR BEFORE **NOON ON MARCH 12, 2019**, USING THE TRIAL DATE OF **AUGUST 5, 2019**. AGREED SCHEDULING ORDERS AND MOTIONS FOR CONTINUANCE WILL BE CONSIDERED BY THE COURT.

EACH PARTY SHALL SUBMIT ITS PROPOSED CHARGE TO THE COURT NO LATER THAN **NOON MARCH 25, 2019**, OR THE DAY REFERRED TO IN THE SCHEDULING ORDER, WHICHEVER IS EARLIER. MOTIONS IN LIMINE WILL BE FILED NO LATER THAN NOON ON THE DAY PRIOR TO JURY SELECTION.
