EACH PARTY SHALL SUBMIT ITS PROPOSED CHARGE TO THE COURT NO LATER THAN NOON FEBRUARY 22, 2019, OR THE DAY REFERRED TO IN THE SCHEDULING ORDER, WHICHEVER IS EARLIER. MOTIONS IN LIMINE WILL BE FILED NO LATER THAN NOON ON THE DAY PRIOR TO JURY SELECTION.
