hereinafter called Grantor, for and in consideration of the issuance to said Grantor by the ECTOR COUNTY BAIL BOND BOARD of a license to act as bondsman in the courts of Ector County, Texas, and in further consideration of the provisions and requirements of paragraph 6(d)(2), Article 2372p-3, Vernon's Annotated Civil Statutes of the State of Texas, has granted, sold and conveyed, and by these presents does grant, sell, and convey to Mark Donaldson, SHERIFF, ECTOR COUNTY, TEXAS, hereinafter called Trustee, and his successors in office forever, the following described property, to-wit:

To have and to hold said premises unto him, the said Trustee, and his successors in office forever, together with all and singular the rights, tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining. And Grantor does hereby bind himself, his heirs, executors and administrators to warrant and forever defend, all and singular, the said premises unto the said Trustee, and his successors in office, against every person whomsoever, lawfully claiming or to claim the same or any part thereof. This conveyance is in trust, however, for the following purposes and upon the following conditions, towit:

If said Grantor shall well and truly pay within thirty (30) days of certified mail demand therefor every judgment of bail forfeiture that results from his, the said Grantor's, execution of a bail bond in any court of Ector County, Texas, then this conveyance shall become null and void, and shall be released at Grantor's cost when said Grantor ceases to engage in the business of executing bail bonds, ceases to maintain his license to engage in such business, and there are no judgments or bond liabilities outstanding against him in Ector County, Texas.

But if Grantor, after such demand, and after the expiration of thirty (30) days therefrom, shall have refused or failed to pay any judgment so resulting, the said Trustee, or his successor in office, as the case may be, is hereby authorized and empowered to sell the above described property, or any lots, tracts, parcels or parts thereof as he may, in his judgment, be necessary and sufficient to pay said judgment, or judgments, as the case may be, to the highest bidder or bidders for cash in hand after advertising the time, place and terms of the sale of all of the above conveyed and described property, or any part thereof (the privilege of selling in whole or in part being hereby granted) for at least twenty-one days successively next before the day of sale, by posting up written or printed notices thereof at three public places in the County in which said real estate is situated, one of which shall be at the Court House Door of such County, to sell the same, in accordance with such advertisement, at public auction, in front of the Court House of the County in which said property is situated, on the first Tuesday in any month between the hours of ten o'clock A.M. and four o'clock P.M. to the highest bidder for cash, selling all property above conveyed as an entirety or in parcels as the Trustee may elect, and make due conveyance to the purchaser or purchasers, with general warranty, binding the said parties of the first part herein and their heirs and assigns.

And it is understood and agreed that the said Trustee, or his successors in office, as the case may be, after said sale or sales as aforesaid, shall execute and deliver to the purchaser or purchasers of said tract or tracts good and sufficient deed or deeds in law to the property so sold, in fee simple, with the usual warranties, and shall receive the proceeds of said sale or sales, as the case may be, and out of the same shall pay: First, all necessary charges, costs and expenses of executing this trust; second, said judgment or judgments, as the case may be, resulting from Grantor's execution of bail bond or bonds in any court in Ector County, Texas, notice of which was given Grantor as aforesaid.

And, further that after such sale and payments as aforesaid, any balance remaining therefrom and thereafter shall be deposited to Grantor's credit with the County Treasurer, Ector County, Texas, to be held by that officer in the Bail Security Fund of his office pending action by Grantor either to replenish the same as provided by law to continue to do business under his license as bondsman, or to relinquish the same and accept cancellation thereof and withdraw his security, or any part thereof remaining, in the manner provided by law when he is no longer surety on any bond in any court in said Ector County, Texas.

It is further understood and agreed, and Grantor further covenants with Trustee that he will at all times during the continuance of this trust, keep the buildings and improvements, if any, now on, or hereafter to be erected on, said premises, insured against loss by fire to the extent insurance can be obtained thereon, in a company or companies acceptable to Trustee and with loss payable to said Trustee, or his successor in office, in the amount of Ten Thousand & No/100 Dollars (\$10,000.00), or so much thereof as constitutes the maximum insurability of said premises against such loss. And, further, that in the event of such loss, and such payment of insurance proceeds to said Trustee, the moneys so received shall be deposited to Grantor's credit with the County Treasurer, Ector County, Texas, to be held by that officer in the Bail Security Fund of his office pending action by Grantor in the same manner, and for the same purpose, as set out in the next preceeding paragraph herein in the case of excess moneys realized from Trustee's sales hereunder.

And it is further stipulated and agreed that in case of any sale hereunder all prerequisites to said sale shall be presumed to have been performed, and that in any conveyance given hereunder all statements of fact, or other recitals therein made, as to the advertisement of sale, or time, place, and manner of sale, or as to any other preliminary act or thing, shall be taken in all courts of law or equity as prima facie evidence that the facts so recited are true.
