CONSIDERATION OF TAX ABATEMENT APPLICATION AND PROPOSED AGREEMENT. To consider, receive public comment upon, and act upon an application and proposed agreements for property tax abatement under Chapter 312 of the Texas Tax Code for the following proposed project:

Property Owner: Oxy Low Carbon Ventures LLC

Applicant for Tax Abatement: SMBC Leasing and Finance, Inc., a Delaware corporation, and 1PointFive Stratos RWTU, LLC, a Delaware limited liability company

Enterprise / Reinvestment Zone: 3.97 acre tract located in a portion of Section 3, Block 15, Public School Land Survey, Abstract 484, Ector County, Texas; Also known as Ector County Appraisal District Parcel Number 46190.00010; with such tract being located in a Reinvestment Zone of Ector County, Texas designated by the Ector County Commissioners Court on July 9, 2024.

Anticipated Improvements: Proposed construction of Raw Water Treatment Unit (RWTU) to receive Raw Water and generate streams of Treated Process Water and Wastewater.

Estimated Cost of the Improvements: Approx. \$170,000,000.00
