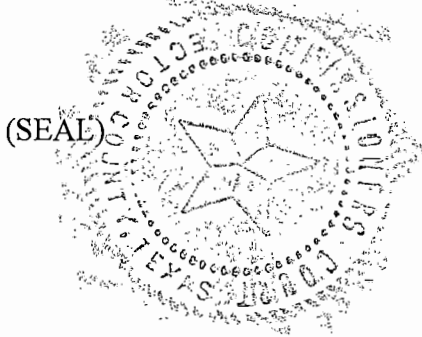

NOTICE IS GIVEN that the Commissioner's Court of Ector County, Texas, will meet at 10:00 A.M., on August 12, 2025, in the Ector County Commissioner's Courtroom in the Ector County Administration Building Annex, 1010 E. 8th St., Odessa, Texas, to hear and consider a Petition for the creation of a district to be named "ECTOR COUNTY ROAD DISTRICT NO. 1".

The creation of the ECTOR COUNTY ROAD DISTRICT NO. 1 is proposed. The Road District is to be created and to operate pursuant to Texas Transportation Code Chapter 257, Subchapter B and to issue bonds pursuant to Chapter 1471 of Texas Government Code in the amount of \$11,000,000. The boundaries of the proposed District, as stated in the Petition, are stated in Exhibit "A", attached.

Each person who has an interest in the creation of the ECTOR COUNTY ROAD DISTRICT NO. 1 may attend the public hearing and present grounds for or against the creation of the District.

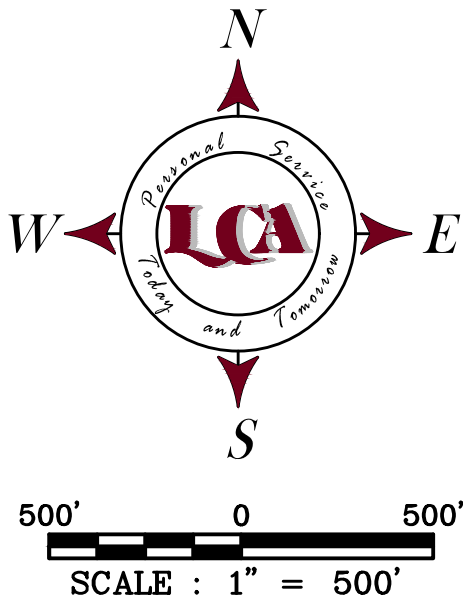
