1. Ector County Library Advisory Committee Report , Randy Ham- Odessa Arts Executive Director

Esperanza Gomez approached the court regarding this item. The machines that have been decided upon will be paid for using ARPA funds. They have an 8 year warranty and the pads that are used will need to be replaced every 4 years at a cost of \$13,000. There will be 28 machines purchased to be placed in all county buildings for a total cost of \$67,908. There will also be training provided to county employees on using the machines.
