The meeting was called to order at 10:00 a.m. by Judge Fawcett.

Survey, Ector County, Texas (Ector County Appraisal District Parcel # 40190.00010.00000) and an application for tax abatement under Chapter 312 of the Texas Tax Code, for construction of a battery energy storage system planned facility project of Seragio BESS, LLC, to be developed by Samsung C&T Renewables, LLC; and to take any necessary action regarding the approval of adoptions of resolutions and the tax abatement agreement with Seragio BESS, LLC/Samsung C&T Renewables, LLC, and authorize the County Judge, County Commissioners, and County Clerk to sign all documents associated with this agenda item.

Lee McClendon, Ector County Attorney stated that the advice received during Executive Session is a matter of attorney client privilege so no details of the meeting would be made public.

Commissioner Simmons stated the court does believe the complaints are valid and the court has concerns but they have been advised that the court has no jurisdiction. He went on to explain that the Commissioner's Court is not a court of finding so it must go through District Court.

Jeff Russell questioned the court to see if the Attorney General had responded to questions asked of

them to which Judge Fawcett stated that he has not heard back but will likely request an official Attorney General Opinion.

Commissioner Simmons stated that the people who are running for a place on the board are the ones who have standing because if ECUD does not hold an election in May then those people can go back to the District Court judge and enjoin the case.

Patti Kappauf replied to Commissioner Simmons stating that the transcript from the case states that the District Court judge said they could go to Commissioner Court.
